


The first step when you harvest a deer on Fort Jackson, is to bring it to the Big Game Check Station at Heise's Pond by the most direct ON-POST route. ALL HARVESTED DEER MUST BE BROUGHT TO THE CHECK STATION


Once you have arrived at the Check Station, affix the appropriate FORT JACKSON DEER QUOTA PROGRAM (DQP) TAG to the animal. Instructions for tagging can be found on the back of the tags. DO NOT USE A PERSONAL TAG.

Follow the instructions posted at the Check Station for checking in deer. Failure to check in deer can result in the loss of hunting privileges.




This includes weighing, measuring antlers, removing a lower jawbone, and filling out a jawbone tag and the harvest log sheet.


In addition to checking in your deer at the Fort Jackson Check Station, the law now requires that all deer harvested in South Carolina be checked in with the SCDNR. The easiest way to do this is through the Go Outdoors SC app.



When you start a harvest report after taking a deer on Fort Jackson, ensure that you click the tab for the Deer Quota Program Tag



Fill out the entire form and submit. The information required for filling out the form will be found on the Fort Jackson DQP tags and from the data recorded when you checked in your deer.



- No deer may be taken off post without a Fort Jackson DQP tag affixed to it.
- Deer may be cleaned at the check station or taken off post to a processor. Processors will not accept deer that have not been checked in through SCDNR.
- If you do clean a deer at the check station, clean up all blood, etc. afterwards. Entrails, hides, etc. are to be placed in a garbage bag and taken to the dumpster located behind the check station.
- Jawbone removal is required for all deer. If you are taking your deer to a taxidermist for mounting, you must return it once the taxidermist has removed it.

Review

- All deer are to be taken to the big game check station at Heise's Pond. TAKE THE MOST DIRECT ON-POST ROUTE!
- Affix a Fort Jackson DQP tag to your harvest. DO NOT USE YOUR PERSONNAL TAGS!
- Fill out the Fort Jackson harvest sheet, pull the jawbone, create a label, place the label and jawbone in a bag, and place in the freezer. PLEASE WRITE LEGIBLY!
- Use the GO Outdoors SC app or phone system to report your harvest. Remember to select the SC DQP tag on the first page. All data required by the state is located either on the DQP tag or on the harvest data sheet. Once submitted you will receive a confirmation number which will be required by all processors. THEY WILL NOT PROCESS A DEER WITHOUT THE CONFIRMATION NUMBER!
